Chapdelaine opened the meeting at 4:30 pm.

1. 2<sup>nd</sup> Budget Work Session with Department Heads (Discussion/Action Item):

a) 4:30 pm - Town Clerk/BCA/Statutory Meetings -

Town Clerk - Items discussed were: amount budgeted for record restoration being reduced, fishing and hunting license revenue and telephone expense. Statutory Meetings – Items discussed were: postage and printing costs.

c) 5:45 pm – Planning Department/DRB - Budget is up .34%. Items discussed were: assistant hours, new computer for Dechert, planning grants and anticipated grant money.

b) 5:00 pm – Lister Department – Budget is up 3.05%. Items discussed were: additional requests in their proposed 6.12% increased budget, appraisal time, office equipment, tax mapping, CLA, BCA prep time, stipends, future assessing plans, increasing transparency and SIGMA software.

d) 6:00 pm – Recreation Department – Budget is up 1.62%. Items discussed were: projected revenues, web-based registration system, Norwich pool maintenance, Town Pool designated fund contribution, recreation field care, equipment, fees, scholarships, grants and Marion Cross School rental fees.

e) 6:30 pm - Town Administration/General Administration/Tracy Hall -

Town Administration - Items discussed were: dues/meetings/education expense, employee incentive pay and compensation study.

General Administration - Items discussed were: server maintenance, equipment designated fund and website support.

Tracy Hall - Budget is up 2.1%. Items discussed were: repairs and maintenance, electricity and building supplies.

Roberts again spoke about reducing budgets and being proactive in these critical and unique times. It was pointed out that the Finance Committee had suggested the 3% increase goal.

Nunan **moved** (2<sup>nd</sup> May) to adjourn. **Motion passed**. Meeting adjourned at 7:22 pm.
