This is the Town Manager's Report for June 2014. Department specific monthly reports are attached.

## General

- The Listers dealt with 31 Grievances. Last year there were 165.
- The Listers lodged the April 1, 2014 Grand List on June 24, 2014.
- A tax sale was conducted on June 18, 2014. The winning bid was \$10,000 and after the taxes and penalties were paid \$7,631.18 was deposited in an interest bearing escrow account.
- CodeRED was implemented in Norwich. The system provides emergency dispatchers and officials the ability to quickly deliver messages to targeted areas of the community or the entire town.
- Roadside mowing was completed on those areas of the Town where wild parsnip is pervasive.
- Bids were received on the FY15 paving program and the replacement of Public Works Truck No. 5. See my separate memorandum on these bids.

# **Projects**

- Facilities Studies
  - o Bread Loaf is continuing work on Part 4 and is waiting for a reduced set of options to do more detailed design and cost estimating.
  - o There was a Public Forum held on June 4, 2014.
- Norwich Pool Permitting The letter from the Agency of Natural Resources on the proposed dam replacement project was reviewed with our consultant who is developing information on a response to ANR's concerns. This will be followed by a meeting with ANR.

#### Assessor

 Now that the Grand List has been lodged work will continue on the three-year cyclical inspection process.

# **Finance Department**

• Delinquent taxes at the end of June were \$136,507. At the same time last year they were \$182,849.

- Met with the public assistance team from Emergency Management and Homeland Security to discuss the closeout of Bridge 41. We have requested an extension for the time to complete the work on the Pool Dam. The current date is September 15, 2015.
- The Selectboard approved using Ledyard Bank as our prime deposit institution. The Treasurer is working with Roberta to make this change.

# **Fire Department and Emergency Management**

- Two members completed Firefighter I training. This course has more than 180 contact hours.
- A number of members completed the Aerial Apparatus Driver Operator course based on the Norwich Aerial Ladder. This course has approximately 48 contact hours.
- Work is continuing on revising our Hazard Mitigation Plan. A meeting was held to help identify hazard areas and possible mitigation steps.

## **Planning Department**

- The Affordable Housing Subcommittee of the Planning Commission is exploring the possibility of housing on the existing fire/police site.
- Historic Preservation Commission Norwich Farms Project Exhibit opened at NHS
  with large crowd including state officials from the Historic Preservation Division and
  the Department of Agriculture.
- Continuing work on the Vital Communities Smart Commute Home Edition Survey.

# **Police Department**

• Six of the 107 calls for service were outside of the officer's normal work schedule.

## **Public Works Department**

• North Coast Services picked up 4,000 lbs. of electronic devices for recycling on June16th. So far, in 2014, 9,000 lbs. of electronic devices have been picked up for recycling from our Transfer Station.

#### Recreation

- The summer brochure was completed and distributed.
- There are 10 youth and 3 adult programs being offered.

# **Assessing**

The Assessor and Listers completed the 2014 grievance hearings. There were 33 appeals initially filed. Two property owners withdrew their appeals. Hearings were held on June 7, 11, 12, 13 and 16. The Board of Listers heard the appeal of 26 taxpayers in person, reviewed the written appeal of 5.

The appeals were discussed and results were issued on June 23<sup>rd</sup>.

The Lister's met with the Assessor on June 24<sup>th</sup> to approve value changes for the 2014 Grand List. A majority of the Board approved the Grand List for 2014.

The Assessor's Office will begin to collect data for a three-year cyclical inspection process. This process is designed to ensure quality and accurate data when valuing both residential and commercial property. The process had been put on hold to assure the timely completion of the Grand List.

• Delinquent Tax collections through June were \$ 22,174. Delinquent Taxes as of June 30, 2014 are \$136,507. Last year at the end of June they were \$ 182,849. Interest collections were \$ 8,559 and penalty collections were \$1,774.

# Fire and FAST Department

Members of the Norwich FAST Squad and Hanover Ambulance saved the life of a Norwich resident. The patient stopped breathing while being treated. The patient was revived by CPR and advanced life support techniques and transported to DHMC. The patient was discharged several days later.

The Capital Facilities Committee met at the firehouse. In addition, an "open house" was held at the firehouse to permit the public to view our facility and give citizens the opportunity to view the building and grounds.

# **Training**

Firefighters Theresa Moore-Poston and Jeff Pearson completed the VT Firefighter 1 course and are certified at the Firefighter 1 level. The Aerial Ladder Driver Operator Course was completed on June 16, 2014. Members are awaiting their certification exam results. FAST Squad training was on behavioral emergencies.

# **Emergency Management**

We are working on a Hazard Mitigation Plan with the Two Rivers Ottauquechee Planning Commission. The VT Division of Emergency Management received our 2014 Local Emergency Operations Plan (LEOP). This is one requirement to receive full disaster or mitigation funding.

Hanover Dispatch is now providing CodeRED emergency communication services to Norwich. Think of it as 9-1-1 in reverse. If, for example, there is a missing child in your part of town, or a severe weather warning, or chemical/gas leaks that may require you to evacuate, your emergency service providers will be able to reach you immediately by

# Tracy Hall:

On June 2<sup>nd</sup> Jay's Septic was here and pumped out the septic system at Tracy Hall.

During the month of June Buildings and Grounds installed two new ADA compliant toiletsone in the women's restroom, and one in the men's restroom. They also took the sinks down in both restrooms and installed new sink drains.

# **Roadside Mowing:**

We moved roadside on the following roads in order to try to stop the spread of wild parsnip: Beaver Meadow Road, Tucker Hill Road, Bragg Hill Road, Elm Street, and Turnpike Road.

#### **Transfer Station:**

North Coast Services picked up 4,000 lbs. of electronic devices for recycling on Jun 16<sup>th</sup>. So far, in 2014, 9,000 lbs. of electronic devices have been picked up for recycling from our Transfer Station.

## Illness and Injury:

Paul Betters was out on medical leave from April 22<sup>nd</sup> through May 12<sup>th</sup>. He came back for one week and has now been out again since May 20<sup>th</sup>. At this point, he is out indefinitely.

## Completed Projects:

- I completed the truck and dump body specs and put it out to bid.
- I submitted an ad to the "Help Wanted" section of the Valley News for seasonal help.
- The remainder of the 2013/2014 paving program was completed during June.
- Vermont State Inspections, service, and repair work was done on all Fire Department vehicles.

#### Pending Projects:

• I will meet with each Public Works employee to go over their performance reviews in July.

- There are three roads left that have not been graded this season. We will be doing them this month.
- We will take down the woven wire fence at the Peisch property, as time permits.
- I am still working on the 5+ year plan for Public Works.
- I will be soliciting prices for the yearly crack sealing on our paved roads that are still in good condition.
- I have contacted Twin State Sand and Gravel, Pike Industries, and Towle Excavation, our gravel and ledge product vendors, about the price of their products for fiscal year 2014/2015. All of these vendors submitted bids for 2013/2014. They are all willing to hold the 2013/2014 pricing for the next fiscal year with no increases.
- Twin State Gravel has also agreed to hold the 2013/2014 pricing on winter sand for the coming fiscal year with no increases.

The details were discussed at a Recreation Council meeting and the Council recommended suggesting to the Select Board to consider re-writing the Town Dog Ordinance to include "No Dogs Allowed at Norwich Athletic Events". Chief Robinson is in support of this and we hope the Select Board will consider it.
