"Underground Utilities" changed to header format

3.10 (G) - Underground Utilities will be moved to Section 5.03 Site Plan Review as new subsection (13) so that one and two unit residences will not be subject to the requirements.

Changes to 3.10(G) were approved by unanimous consent

4.08(B) and (C) - Home Business/Industry Traffic – No changes by unanimous consent

5.03(D)(1)b - District Standards - No changes except remove "public" from 5.03(D)(2)b

A motion was made to approve these changes. The motion was seconded and **approved** 7-0-1 (McGrew abstained)

Section 3.05 - Existing Small Lots – After discussion, a proposed revision to not force the merger of small lots under common ownership was approved by 7-0-1 (McRee abstaining)

Section 3.14 - Fire Protection – Issues include the balance between the safety benefit to the public and firefighters and the additional cost to those building new homes. Discussion concerned the disparity in the estimated costs of residential sprinkler systems in new construction provided to the commission by the Norwich Fire Department and a member of the public. Dechert will research actual costs for systems installed in new homes in the area for the next meeting.
