Preliminary Notice of the Results of the 2016 Reappraisal

The Town of Norwich contracted with New England Municipal Consultants, Ltd. (NEMC) for a complete reappraisal of all real estate within the town for the 2016 Grand List. As a portion of that contract, NEMC is required to hold informal public hearings to discuss the new proposed values with property owners. This booklet is a presentation of the proposed 2016 values. **This notice does not constitute the beginning of the legal grievance period. You will be officially notified of your Grand List value in May.**

The enclosed proposed valuation list is ordered by location. The list contains the parcel number, owner's name, the property location, the total acreage, your prior (2015) grand list value and the proposed 2016 grand list value. **Please note that 2016 values are not adjusted for current use. Current use adjustments will be applied prior to the release of the official abstract.**

The last full reappraisal completed in Norwich was in 2013. In August of 2013, NEMC began a cyclical inspection program to collect information on the homes and businesses in Norwich. Upon completion of the property inspections, the senior project manager established new values for all property by analyzing the sales of property within Norwich. The results were applied to the appraisal of land and buildings in Norwich. The project supervisor personally reviewed the appraisal for each property.

The Board of Listers has given its preliminary approval to the project. The next step is for property owners to have the chance to discuss informally the new appraisal with the staff of NEMC. In this process, you, the property owner, have the opportunity to sit and discuss the new value, the reasoning behind it, and the data used to arrive at the new value. The key to the process is a discussion of fair market value. Vermont law states that all taxable property in the State must be appraised at fair market value. Fair market value can best be described as the value you might reasonably expect to receive upon sale of your property in a fair, considered transaction.

The enclosed proposed value is an indication of the market value of your property as of April 1, 2016. Please be aware that there are only three ways to change your new assessment.

1. The new value is not fair market. Simply, you feel your property is not worth what the new assessment has been set at.
2. The property is not fairly assessed when compared to other similar property. When you compare your property to reasonably similar property, in a similar location, you should see that the assessments are similar.
3. There may be data errors in your record. You can get a copy of your record at the informal hearing or beforehand from the Assessing Clerk.

If you feel that the proposed value is not a fair indication of market value for your property, you can schedule an informal meeting with NEMC representatives. You will be given the opportunity at that meeting to potentially adjust your value based on the market value of the property. You should be prepared to compare your property to other similar homes, bring data about the condition of your house or land, or bring any appraisal or sale documents you may have. The process is meant to be informal and informative. The goal is to have fair and equitable property values for all.

Please be aware that the values contained herein are proposed and subject to change based on information gathered prior to the issuance of the Grand List Abstract.

All valuations are also posted to the Town's website at www.Norwich.vt.us. Please click on the link on the *Assessor/Lister* tab under *Departments*.

Each hearing will be scheduled for 10-15 minutes. You will be provided with a copy of your new property record card. NEMC representatives will make notes and view the property at a later time if needed. You will be notified of any change through the grievance notice you receive in late May.

The informal hearings will be held on May 11 – 14, 2016, at Tracy Hall in Norwich. Daytime and evening hours will be available. Please e-mail the office at assessing-clerk@norwich.vt.us or call (802) 649 1419 x6 to set up an appointment. The office is open Monday through Friday from 8:30 am to 4:30 pm. If no one answers when you call, please leave a message and someone will get back to you. If you cannot attend a meeting please send any information to the Assessor's Office to support your contentions. The address is P.O. Box 376, Norwich, Vermont 05055-0376.
