Thank you to Stuart for including us on his correspondence with the Select Board, Planning Board and Town Staff.

As you may know, Twin Pines spent a considerable sum this summer and fall reviewing the possibility of doing a homeownership project on the Britton parcel on Goodrich Four Corners Road. Unfortunately, there were significant limitations with the parcel around its septic capacity and the Green Mountain Power ROW along the edge of the property that reduced the potential for a homeownership project. The project was too small to make economic sense for Twin Pines to pursue. It is also smaller than the Vermont Housing and Conservation Board (a major funder for such homeownership efforts) likes to see for new homeownership projects given the difficulties of long-term self-management. Twin Pines Housing continues to look at other sites in Norwich for potential rental development, as well as work on efforts to upgrade its existing homeownership project at Starlake Lane with the introduction of a solar field to serve the 14 homes there. This latter effort is well underway and we hope to bring solar to residents there later this year.

Please let us know if you have questions about these efforts and know that we continue to look at options to bring additional affordable housing to the Town of Norwich.
