Request for Bids
2019 Winter Sand
(Fiscal Year 2019-2020)

1. DESCRIPTION

1.1 The Town of Norwich is seeking bids for winter sand for fiscal year 2019-2020.

2. INSTRUCTIONS TO BIDDERS

- 2.1 Proposals shall be typewritten or written in ink. Officials of corporations shall designate their official title; partners or sole owners shall so state giving the names of all interested parties. The person signing the bid shall initial all corrections or erasures.
- 2.2 In submitting a bid the contractor agrees that acceptance of any bid by the Town of Norwich within 90 calendar days constitutes a contract. No work shall be started until a purchase order has been approved by the Town Manager and a Notice to Proceed in writing from the Director of Public Works.
- 2.3 Payment shall be made within 30 days of the completion of work by the vendor and formal acceptance by the Town.
- 2.4 All materials shall remain the property of the seller until delivered to and accepted by the Town.
- 2.5 Deviations from the attached specifications are permitted if defined in detail under Exclusions on the Proposal Form.
- 2.6 Selection criteria: This bid shall be awarded to the vendor whose bid represents the best value to the Town of Norwich.
- 2.7 The Town of Norwich reserves the right to accept and reject any and all bids for due cause, to negotiate with any part, to waive informalities or defects in bids, to require test proving or to accept such bids or parts thereof as it shall deem in the best interest of the Town.

- 2.9 Interested parties shall submit their bid in a sealed envelope, marked "2019 Winter Sand" to Larry Wiggins, Public Works Director at the Norwich Public Works facility at 26 New Boston Road, Norwich, Vermont, 05055 by 10:00 AM August 16, 2019.**
- 2.10 Bid prices shall remain in full force until June 30, 2020.

3. GENERAL INFORMATION

- 3.1 The quantity of sand purchased by the Town of Norwich will be approximately 10,000 tons. This is a blanket bid for the purchase of winter screened sand to be ordered, "as needed", with no guarantee of consumption.
- 3.2 All winter sand shall be delivered to the Public Works Garage at 26 New Boston Road, Norwich, Vt.
- 3.3 The decision as to what vendor will be utilized for which product will be based on several different factors including, but not necessarily limited to, price, vendor location to job site, product quality, or any combination of these and other pertinent issues.
- 3.4 The successful bidder will deliver screened winter sand to the Norwich Public Works Facility between the hours of 7:00 a.m. and 3:30 p.m., Monday through Friday. The total tons of contracted winter sand shall be delivered to the Norwich Public Works Facility before October 1, 2019.
- 3.5 The Norwich Public Works Department will provide road salt to the Contractor to create a stockpile with a mixture of salt to sand, as determined by the Norwich Public Works Director.
- 3.6 The successful bidder will provide all equipment required for stockpiling sand at the Norwich Public Works Facility.
- 3.7 Payment for material supplied shall be based on delivery tickets, submitted daily. Loads shall be weighed (in tons) by approved (State of Vermont/New Hampshire approved) scales as approved by the Norwich Public Works Director.

4. SPECIFICATIONS

- 4.1 All materials must pass the sieve analysis specification included in this bid document.
- 4.2 The Town of Norwich reserves the right to have the materials tested at any time to determine quality.
- 4.3 Should the materials fail to meet specifications, the contracted services will terminate at that point.
- 4.4 Screened sand shall be free of debris such as sticks and sod along with other harmful substances.

5. INDEMNIFICATION AND INSURANCE

- 5.1.1 The contractor agrees to defend and save harmless the Town of Norwich, its officers, agents and employees against all claims, demands, payments, suits, actions, recovery, and judgments of every kind and description arising out of the performance of the Agreement, including personal injury or property damage brought or recovered against it by reason of any negligent action or omission of the consultant, its agents, or employees and with respect to the degree to which the Town is free from negligence on the part of itself, its employees and agents.
- 5.1.2 The contractor shall carry Comprehensive Broad Form General Liability Insurance in the amount shown below including protection for bodily injury and property damage.
- 5.1.3 The contractor shall also maintain Automobile Liability Insurance providing limits prescribed by the Town and Umbrella or Excess Liability Insurance in the amount shown below. The Workers' Compensation Insurance shall provide coverage pursuant to V. S. A. Title 21, Section 600 et seq.

- 5.1.4 Prior to the commencement of work, Certificates of Insurance shall be supplied to the Town by the contractor detailing the required coverage. These Certificates shall be issued by a carrier authorized to do business within the State of Vermont. The Town shall also be named as an additional insured.

- 5.1.5 The contractor shall have and require all sub-contractors to have and maintain insurance coverage and list the Town as an additional insured in accordance with the minimum amounts listed below. Prior to the start of any work, the Town shall be furnished with an insurance certificate as proof that coverage is in place.
 - 5.1.5.1 General Liability-\$1,000,000 per occurrence
 - 5.1.5.2 Product Liability-\$1,000,000 per occurrence
 - 5.1.5.3 Property Damage-\$1,000,000 per occurrence
 - 5.1.5.4 Personal Injury - \$1,000,000 per occurrence
 - 5.1.5.5 Automotive Liability-\$500,000 per occurrence
 - 5.1.5.6 Workers' Compensation-Statutory Requirement
