The Chair opened the Public Hearing at 7:30 PM

A motion was made by Stucker and seconded by Dean to enter all of the Exhibits listed above into the record. The motion passed 6-0.

Site Visit Report: Dechert reported - 4:30 PM at 320 US Route 5 South – Present: Members: Lawe, Dean, Carroll, Stucker, and Teeter - Clerk: Dechert - Applicants: Cappy Nunlist, Andrew Garthwaite, Sean Donovan Public: Bill Brawley

The DRB viewed interior and exterior of building, parking area and proposed parking spaces in setback from Palmer Court. Carroll & Stucker viewed potential parking area 200 yards west off Palmer Court.

Cappy Nunlist, President of the Unitarian Universalist Congregation of the Upper Valley, gave a history of the congregation and its search for a permanent home. Andrew Garthwaite, architect for the project, explained the site and building plans. The existing Greek revival farm house section will be preserved and renovated inside. Newer sections of the existing building will be removed and replaced with a new entry area and meeting room. The maximum capacity of the meeting room will be 120.

The entrance to the site will continue to be from Route 5 South but will be reconfigured to Vtrans standards. The exit will be relocated from Route 5 to Palmer Court in Hartford. Parking will be reconfigured to 11 spaces. Permission for an additional two spaces within the setback

from Palmer Court has been requested. Additional off-site parking on evenings and weekends is available at the Family Place at two locations, 14 spaces at 319 US Route 5 S directly across from the site and 35 spaces on Olcott Drive in Hartford. Also, an additional 20 spaces will be available at the office building south of Palmer Court.

Exterior lighting includes two parking lot lights on 20' pole with "cutoff" fixtures and ceiling lights over the entrances. Lighting will be controlled with timers, and motion and light sensors. Parking will be screened with trees and low bushes. The electrical, phone and data utility lines will be underground from a street pole to the building.

Pedestrian crossing of Route 5 discussed. Although there are good site lines and low traffic on Sundays, it still may be advisable to provide crossing assistance for larger special events when the Family Place parking is used.

Dean moved to close the hearing. Stucker seconded the motion and the motion passed 6-0. The hearing was closed at 8:54 PM

The meeting was adjourned at 9:01 PM.
