1. Approve Agenda
Allen moved and Romano seconded a motion to approve the Agenda. After a roll call vote motion carried 6—0—1.
2. Meeting Objectives:
 - o Discuss possible response to allegations that the 2020 Town Plan is based on actions that violated the Open Meeting Law (OML) made by Commissioner Ciccotelli and Messrs Richards and Wilberding.
3. Public Comment: Richards asked what was happening about the wastewater study and the Marion Cross School (MCS).
4. Horwitz moved and Allen seconded a motion to enter into Executive Session with town legal counsel where it is established under 1 VSA §313(a):
(1) that premature public knowledge would clearly place the public body or a person involved at a substantial disadvantage:
 - (F) confidential attorney-client communications for the purpose of providing professional legal services to the bodyAND
1 V.S.A. § 313(a):
 - (6) [to consider] records exempt from access to public records provisions of section 316 of [Title 1]; provided, however, that discussion of the exempt record shall not itself permit an extension of the executive session to the general subject to which the record pertains.

After a roll call vote motion carried 5—2.

The meeting entered into executive session at approximately 6:37pm

The meeting exited executive session at approximately 8:22pm

5. Any announcement or decision following an Executive Session:
Lubell moved and Loeb seconded a motion to provide a letter with the following text:
Messrs Richards and Wilberding,

Thank you for your letter of October 16, 2020.

On October 22, 2020, the Planning Commission met to consider your concerns and adopted a series of actions intended to reduce confusion and any possibility of a future Open Meeting Law violation. Those actions are described in the minutes from that meeting, which are attached.

As the Planning Commission noted in the October 22, meeting, the concerns you raised do not require the invalidation of the town plan.

Cook said that she could not see the chat text because she was joining by phone. Lubell offered to send Richards and Cook the text agreed upon.
