5. Subdivision Regulation Revisions –

- a. Storm Water Management and Erosion Control 3.5 A revised draft dated July 18, 2012 was revised to include a requirement that development resulting in a disturbed area of contiguous property with slope grades exceeding an average of 25% is required to have a stormwater management and/or erosion prevention and sediment control plan as described in (C). These changes were approved 5-0. This change was proposed at the July 12 meeting.
- b. <u>Public Workshop</u> A public workshop for review of the amended subdivision regulations will be on August 23 at 7 PM. (**Note:** This was later changed to September 27th due to a schedule conflict.)

6. Zoning Amendment – River/Stream Corridor Management

The Commission began the process of researching and writing a revised section on stream and river protection based on the existing Blood Brook Fluvial Erosion Hazard (FEH) mapping created several years ago, guidelines created by the Rivers Management Program at Vermont ANR, and the experience gained from Tropical Storm Irene. Members reviewed a map of the entire length of Blood Brook and its major tributaries showing the existing protection areas and the proposed protection areas based on the FEH study.

A workshop with Gretchen Alexander, a rivers scientist from the Rivers Management Program, is scheduled for September 13 at 7 PM.
