a. Section 248a Permitting – The 45-day pre-application notice was submitted and distributed by the town on April 26, 2013. The statute establishes that:

"A rebuttable presumption respecting compliance with the applicable plan [Town Plan] shall be created by a letter from an affected municipal legislative body or municipal planning commission concerning compliance with the municipal plan and by a letter from a regional planning commission concerning compliance with the regional plan. - 30 VSA 248A (c)(2)"

After review of a draft of a letter prepared by the clerk from the Planning Commission to the Public Service Board certifying compliance with the town plan and zoning bylaws, Johnson moved to approve the letter. The motion was seconded by Stucker and approved 5-0. After final edits and formatting, the letter will be reviewed and signed by the Chair.
