Article II - Table of Permitted & Conditional Uses by District – Several changes were made including:

- a. Removing new single family or two family residential structures from the Commercial/Industrial District. Residential accessory structures and uses remain
- b. "Primitive Camps" was added as a permitted use in the RR District
- c. Indoor Recreational Facility was added to the RR District as a Conditional Use with Site Plan Review (C/S)
- d. Contractors Yard was added to the RR and VRII Districts as a Conditional Use with Site Plan Review (C/S)
- e. Adaptive Reuse was added to all districts as a Conditional Use with Site Plan Review (C/S)
