 - 2. Town Manager, Herb Durfee, ("Durfee") will connect with Peter Gregory of Two Rivers to review the revised plan and gather regional input
 - 3. Planning Commission will hold a special meeting on Thursday, May 31st, at 6:30 pm, to discuss comments on the Town Plan changes and develop a document for the Selectboard to be delivered by June 6th.
