NORWICH HISTORIC PRESERVATION COMMISSION MINUTES

1. Approve Agenda

Phil Zea moved to approve the agenda; Maggie Boone seconded the motion. The motion to approve the agenda passed (5-0).

2. Public Comment

There was no public comment.

3. Review and Approval of the Minutes of the September 28, 2023 Meeting

Maggie Boone moved to approve the minutes as drafted; Phil Zea seconded the motion. The motion to approve the minutes passed (5-0).

4. Discuss Applying for a 2024 CLG Grant

The Commission discussed a potential 2024 CLG grant application to support the Norwich Community Collaborative Inc.'s ("NCC") restoration of the historic Grange building.

Nancy Osgood made the following motion:

To submit, in coordination with the NCC, an application to the Vermont Division of Historic Preservation for a CLG grant, to cover the cost of preparing architectural drawings related to the building's rehabilitation.

Phil Zea seconded. Nancy Osgood, Phil Zea, and Linda Cook voted in favor of the motion, which passed (3-0); while Jess Phelps and Maggie Boone recused themselves and abstained from the vote because of their involvement with the NCC.

Nancy will submit a letter to the Selectboard to obtain their approval for the Town Manager to sign off on the grant submission and will plan on attending the November 21st Selectboard meeting to answer any questions about the grant application.

5. Other Business

- The NHPC discussed the next steps on publicity for the Jones Circle National Register project and will reach out about a potential *Norwich Times* article on same. Work continues on the nomination and the Commission discussed next steps on ensuring we are complying with our volunteer obligations.
- Nancy Osgood had a few corrections to the NHPC website which will be made to make sure the links are working.
- The NHPC will plan to connect with the Energy Commission and Planning Commission next year to advance shared goals.
- The NHPC continues to need additional commissioners.
