Additional correspondence:

As a bicyclist who has biked on Route 5 for both exercise (good for my health) and commuting to work (good for the planet), I can attest to how important it is to have a paved road with wide shoulders in good condition. I used to bike commute from Norwich to White River Junction. I would ride part way on Route 5, but with the cracked pavement and narrow shoulders I did not feel safe in traffic, and so would ride the rest of the way on side roads with less traffic. The section of Route 5 between Norwich and East Thetford was repaved a few years ago and that made an enormous difference. Before then, fellow cyclists and I avoided Route 5 due to the broken pavement and crumbling narrow shoulders. Now it feels much safer. Though, ideally it could be a bit wider. For example, Route 10 in NH from Hanover to Lyme has a wide shoulder that allows cars to pass cyclists at a safe distance. A narrow road is unsafe for bicyclists and is also frustrating for drivers waiting for a safe opportunity to pass. A Route 5 bike corridor with improved bike lanes would also greatly benefit recreational cycling events, such as the annual Prouty fundraiser that typically uses Route 5 from East Thetford up to Wells River. Hi - thanks for your note in the Norwich list serve today about the route 5 bike corridor. I am an enthusiastic supporter of the project.

There have been some horrific bike accidents on route 5 which is a heavily used bike route.

I wonder if a rail trail might be a better use of the tracks than the two trains a day currently using the track.

My experience with rail trail use in NH, VT, various other states and in Europe is "if you build it they will come". It supports the local economies and the health of the community by providing a safe space for exercise and outdoor activity.
